**SESSION 47** *\*Simultaneous interpretation is not available for this session***New Regulation “Greek Agricultural Insurance Organisation” (ELGA)**

The political Leadership of the Ministry of Rural Development and Food and the Administration of the Hellenic Agricultural Insurance Organization have agreed to ensure the financial robustness of the Organization, aiming at the creation of a strong Agricultural Insurance Agency whose finances allow the fulfillment of its obligations despite the heavy damages caused by the extreme weather phenomena. The extreme weather phenomena which are a consequence of the climate crisis cause severe damage to cultivations of plant and animal life, resulting in expenses for compensation for damages which are covered by the ELGA Regulation, to exceed by a long shot from the income from the special insurance levy. It is necessary to find new resources to ensure the financial stability of ELGA both at the level of the current Regulation and in the future with a new Regulation which will include compensations for new risks and new threats. Reformation of the administrative structure and operation is required by ELGA, aiming at reinforcing the effectiveness of the Organization. The digital transformation of the Organization will strengthen the relationship between producers and Organization and will significantly reduce the period between personalized assessments and payment of compensations.

Pop2See team won 1st place in the Greek qualifiers and, together with one more team, they represented Greece in the World Robot Olympiad 2022, in November in Dortmund, in Germany.

#### MUSICAL HERITAGE REHABILITATION FOR MULTIPLIER CULTURAL EMPOWERMENT - HERMES

By the Classical Music Orchestra of the Department of Music Studies, University of Ioannina and the Polyphonic Choir of Patras

The symphony orchestra of the Department of Music Studies of the University of Ioannina, which is the first complete university symphony orchestra in Greece at a regional level, in collaboration with the Polyphonic Choir of Patras, come to highlight a rare cultural heritage originating from Greek musicians of the Ionian Islands of the 19th century and the beginning of the 20th century. The Ionian Islands (Heptanese) were the center of development of modern Greek music. Until Athens took precedence, the Ionian Islands were a special artistic peak of regional Hellenism due to their proximity to Italy and the previous Venetian Occupation. The first Greek symphonic music was created there, which unfortunately remains largely unknown to this day.

Music Composers such as Antonios Livalis (1814-1842), Nikolaos Metaxas Tzanis (1824-1907), Dimitrios Andronis (1865-1918?) and Lavrentios Kamilleris (1875-1956) wrote masterpieces in the field of symphonic and dramatic music. The Department of Music Studies of the University of Ioannina, joining forces in research, musicology and performance, presents selected works of the aforementioned music composers for soloists and orchestra.
